Security and Policing Exhibition - Attended a one day briefing by the Home Office finding out about the support available for Businesses and Event planner and Spaces and requirements for the future. Will be using some of these resources available for Romsey and the planning of events.

Easter Trail – was run by Moonstones, Dukes Keep who is also running a market and activities over Easter. Fun days at Kings John House and many of the churches and local halls which have been promoted on social media.

Romsey Business and Brew The new Chamber breakfast meeting held its second event at Romsey Town Council. With sponsorship from Reeve the Baker to support the new launch it was attended by over 30 businesses and retailers from the town.

Issues still outstanding: State of pavements in the town.

Event priorities have been:

- Events sign up form currently written signed off by Test Valley, as of 27/03 awaiting a response from Police and Fire Brigade.
- Events Toolkit and Marshal Safety / Training
- Preparation for Antiques Fair, Christmas events, Beggars Fair managing schedules, operations, security, training, and protocols for each event. Taking advice from different parties on the complexed needs to prove the security and safety of the town during events.
- Beggars Fair 30th anniversary event events throughout the year, partnership with other organisations/businesses, event parking, promotion / marketing, and funding.

Business

Romsey Job Fair went successfully however due to extensive flooding, major road closures and two big Job Centre events either side of the day it was slightly less attended by businesses. The next one will be in September and then again in March/April 2025

Promoting 'Cross – Chamber Connections' was organised by the Romsey Chamber as a joint event with Salisbury and District Chamber of Commerce which was attended by 60 businesses wanting to network with businesses in these areas. It was a huge success which has already achieve some positive collaborations.

Community

The Romsey Food Partnership was set up to create a working group to help and assist those in Romsey and Test Valley gain the support they need by bringing in key businesses to help facilitate new programmes, funding, and partnerships. The partnership is now in talks with Andover Food partnership to merge into a wider Test Valley working group which will employ a Co-ordinator funded for 2 years, who with the guidance and help from the Partnership Groups, will run projects throughout the Test Valley. They have 25k to fund this position but need to match fund this position. Working on the Romsey Food Fair committee I have agreed to give the group a charity stall for 2024.

Attended Test Valley South Locality Health Forum to understand the problems and opportunities to our health service in South Test Valley. This going forward will now be passed to Cllr S Gidley to attend.
