Humby and Highways Officers to The Hundred and brought to their attention several issues which need to be considered regarding the road/pavements. ## 15. MAYORAL ANNOUNCEMENTS

As this is the last Full Council meeting before the elections in May 2023 The Mayor, Cllr. N. Gwynne thanked all Councillors for their hard work and support over the last four years. A special thanks was given to Cllr. D. Baverstock who after 20 years service both on RTC and TVBC is retiring. Cllr. M. Cooper said it is a great pleasure to support and amplify Cllr. Baverstock's achievements as follows:-

When Dorothy was elected to this Council, and to Test Valley Borough Council, on the 1st of May 2003, she had already spent many years serving Romsey and Romsey School as the Deputy Head Teacher, Community. That she has continued on Town and Borough for 20 years is testament to her stamina and commitment to Romsey and its residents.

She replaced Brian Palmer in Cupernham ward serving with Alan Marsh until 2007, followed by Karen Dunleavey until 2015, John Ray until 2019, then Janet Burnage and Neil Gywnne until now. And every time, Dorothy has topped the Ward vote, and that's not just because her surname begins with 'B'.

She has always been prepared to take on additional responsibilities including Town Mayor in 2004 and 2015 and Borough Mayor in 2012. Additionally, she has served on Romsey Extra Parish Council for eight years.

As a Councillor she has always been a strong and vocal advocate of tourism in the town and of the town's open spaces where the War Memorial Park's Green Flag owes much to her efforts. In recent years she has campaigned successfully for additional Security Guards over Romsey's Christmas period.

One of my lasting memories of Dorothy over the last few years has been the midevening telephone call... "That'll be Dorothy," I say, when the phone goes... and sure enough it is and Dorothy says.... "Mark; I'VE GOT AN IDEA..." and from those thoughts a very significant benefit has, over the years, been delivered to the people of Romsey.

Her commitment to other organisations in the town is truly impressive including many years of service in the Romsey Show Society; King John's House; The Test Valley Arts Foundation; and Romsey CAB. Outstanding successes, beyond the parameters of politics, include Chairing the War Horse project which raised £80,000 resulting in the unveiling of the Amy Goodman's brilliant War Horse statue in the War Memorial Park in July 2015 and also Dorothy's long term involvement with Unity which works across the whole of Test Valley and which and co-ordinates local organisations that support the vulnerable in our community and which she has chaired for many years. When Dorothy was awarded her British Empire Medal in 2020, Unity's Chief Executive said of Dorothy; "She is a powerhouse of energy and enthusiasm."

I can't better that, other than to say, on behalf of the people of Romsey,

'Thank you, Dorothy.'
